## New Board Elected on March 14, 2010

On the same day, the newly elected ATCMS Board had its first general meeting and elected Drs. Yong Ming Li and John Pai as the member of Supervision Committee, and voted Drs. Hello, everyone. Here is an update on where we stand with legislative action. First let me extend a thank you to all those who have already sent in letters to their local assembly members in support of the SAME-AS Insurance Parity Bill in the senate S7498 to A9097 in the assembly and Herbal Bill(A3717/S5512). We have a limited window of time to get these bills through the assigned committees (Insurance and Higher Education). If you have not already done so, than we urge you to use votesmart.org to find the contact information for your legislator and ask for co-sponsorship on these bills.

At the recent AAAOM convention the was a presentation on ICD codes by Dr. Molly Robinson, a representative of the World Health Organization (WHO). This project seeks to include our diagnostics into the ICD coding system, which represents a fundamental shift from the inclusion of only Western diagnostics.

There is a movement in the profession of physical therapy that can potentially effect us as acupuncturists. It is called TDN or trigger point dry needling and some states have already included it in the scope of practice of physical therapy. For more information see these links
