# ATCMS Spring Seminar on March 30, 2014 Clinical Application of Conventional Acupuncture and Zheng's Acupuncturemoxibustion Skills

Speaker: Prof. Xiaoli Fang, Dean of Acupuncture and Massage Department,
Gansu University of TCM

Spring is a time when everything begins to grow in a year. To celebrate this season, ATCMS has invited Prof. Xiaoli Fang, student and academic successor of Prof. Zheng Kuishan, "Northwest Acupuncture King" and father of contemporary Chinese acupuncture research, to visit NYC and share her experience of clinical application of conventional acupuncture and Zheng's acupuncture-moxibustion skills during the upcoming seminar dated on March 30, 2014. Prof. Fang is currently a doctoral advisor and leading personnel in Gansu Province. She has studied under Prof. Zheng Kuishan, well-known domestic and abroad, and has engaged in teaching, scientific research and clinical practice of acupuncture and moxibustion for 28 years. At present she holds the position of Director of Acupuncture and Massage Department in Gansu University of TCM, Deputy Director of Clinical Center for Acupuncture and Moxibustion in Gansu Province, Deputy Head of Gansu Institute of Acupuncture and Moxibustion, Deputy Head and Secretary General of the Research Association of Zheng's Acupuncture-moxibustion Skills, Vice-President of Academy of Huang Fumi's Acupuncture and Moxibustion in Gansu Province, Member of the Section of China Institute of Acupuncture and Moxibustion, Member of the Committee for Natural Therapeutics of WFCMS Specialty Committee.

Prof. Fang has persisted in combining theory with practice for years. Through long years of clinical practice of acupuncture and moxibustion, she is good at treating various acute and chronic pain diseases, sequela of apoplexy, diseases of five organs on the head (fundus oculi disease, xerophthalmia, tinnitus and deafness, Bell's palsy, acne, migraine and rhinopathia, etc.), enteric disease, cough, asthma, insomnia, vertigo, obesity, menstruation diseases, rheumatism, osteoarthrosis and various difficult and complicated diseases with Zheng's Acupuncture-moxibustion Skills, conventional acupuncture manipulation and Holographic Cheek Acupuncture Therapy. On inheriting Zheng's needling techniques of "Guoyan Re" (Heat beyond the eyes) and "Chuanjia Re" (ates the scapula) of "Warmingproducing Needling for Removing Obstruction", she has taken advantage of and developed the needling techniques of "Tongdu Re" (Heat through GV channel) and "Zhoutian Re" (Heat via circle of vital energy) to treat various kinds of difficult and complicated diseases with better effect. She has directed, participated in and completed ten scientific research tasks above provincial level. As academic successor of Prof. Zheng Kuishan, she has directed and completed the research tasks on Zheng Kuishan's academic ideas and clinical experience for acupuncture and moxibustion during the Eleventh Five-year Period of National Key Scientific & Technological Project Research on Academic Ideas and Clinical Experience of Famous Veteran Doctors of TCM like Zheng Kuishan, Yu Jibai and Zhou Xinyou, and has achieved several awards in scientific research. At present, she undertakes 3 scientific research projects of National Natural Science Fund and State Administration of Traditional Chinese Medicine. She was a chief editor of 2 books, including "A Collection of Zheng Kuishan's Clinical Experience of Acupuncture and Moxibustion", "Therapeutics for Conventional Acupuncture Manipulation", and vice-editor-in-chief of 4 books, including Prevention and Treatment of Diseases by Pressing Acupoint along Meridian and Choice Collection of Huang Fumi's Medical Work, etc. Prof. Fang also edited 3 books, including "A Treasury of Chinese Acupuncture Techniques", etc. She has published more than 50 papers in national and provincial publications.

The topics of Prof. Fang's lecture on 3/30/14 are drawn from her personal clinical experience in treating common clinical diseases and difficult and complicated diseases, applying conventional acupuncture techniques and Zheng's acupuncture-moxibustion skills. The highlights of the lecture are as follow:

- 1. Classical traditional acupuncture manipulation: introduce manipulation and clinical application of some classical traditional acupuncture techniques, such as heat-inducing needling, cool-inducing needling, moving Qi along meridians; introduce combination of syndrome differentiation, acupoint selection and manipulation in clinical acupuncture, in light of eight needling methods established by Prof. Zheng Kuishan, that is "sweating, vomiting, purgation, harmonization, warming, elimination, digestion and tonification". For instance, sweating is a treatment technique which applies acupoint prescription in combination with acupuncture manipulation to open striae to sweat and eliminate pathogenic factors so as to treat superficial syndrome. To transpire wind cold: select GB20, GV14, LI4 and SI3 with heat-inducing needling to generate heat and make sweat. Its indications are some exterior cold syndrome, such as common cold, headache, aversion to cold, fever with no sweating, floating and tense pulse.
- 2. Zheng's family inheriting and innovative acupuncture manipulation: introduce manipulation and clinical application of heat-reinforcement and cool-purgation needling as well as "Warming-producing Needling for Removing Obstruction" of Zheng's innovative acupuncture manipulation. a. Treatment for head, face, five sense organs (tinnitus, deafness, migraine, prosopalgia, Bell's palsy, "Guoyan Re" to treat eye diseases, etc.). b. Utilize "Chuanjia Re" to treat diseases of neck, shoulder and arm. c. To treat Alzheimers and sequel of cerebral infarction.

- 3. Zheng Kuishan's theory and practice of basic skills of acupuncture: introduce exposition and practice of ways and methods of acupuncturists grasping basic skills and improving curative effect of acupuncture by Zheng Kuishan. Examples are how acupuncturists could self-cultivate and carry out practice of acupuncture, as well as improve their ability of acupuncture manipulation.
- 4. Principle of clinical application for conventional acupuncture manipulation: Elaborate prerequisite and basic demands for implementation of conventional acupuncture, explain core of acupuncture reinforcementreduction as well as key to its curative effect in order to enhance clinical efficacy of treating difficult and complicated diseases by acupuncture.

Conventional acupuncture manipulation has been regarded as important step of affecting clinical efficacy of acupuncture. Since Prof. Fang has studied under Prof. Zheng Kuishan and with nearly thirty years of clinical and teaching practice, her mastery and application of conventional acupuncture techniques has reached a high level. She was often invited to give academic reports and demonstration of conventional acupuncture manipulation domestic and abroad. Her manipulation is comfortable and of rapid curative effect with the advantage of less acupoints, quicker effect as well as better effect for difficult and complicated diseases.

This seminar will be held at Sheraton LaGuardia East Hotel (135-20 39th Avenue), in Flushing, NY 11354, from 10:30 a.m. to 5:00 p.m. on Sunday, March 30, 2014. During the seminar, Prof. Fang will demonstrate her acupuncture techniques of "Guoyan Re" and "Chuanjia Re" which belong to Zheng's acupuncture-moxibustion school of thoughts.

The second topic of this upcoming seminar will be presented by Dr. Ling Zheng. During his 60-minute-talk, Dr. Zheng will introduce the revised CMS-1500 Form and explain the differences between the revised form and original one. Also, Dr. Zheng will introduce the new ICD Codes and explain how to use these codes correctly. ATCMS will provide every attendee with a free copy of <<The List of ICD-10 Codes Commonly Used by Acupuncturists>>. The reference information listing about 400 new ICD codes commonly used by acupuncturists and the description in both English and Chinese, was selected and edited by Dr. Ling Zheng, based on <<ICD-10-CM>> published by AMA at the beginning of 2014. It should be a useful tool for acupuncture practitioners on the insurance reimbursement. According to regulations of CMS, insurance companies will only accept the revised CMS-1500 Form starting April 1, 2014, and require healthcare providers using ICD-10 codes for medical reimbursements starting October 1, 2014.

### 2014 ATCMS Membership


